

### Methodists Will Move Into New Church Sunday

Moving in day at the new Southern Pines Methodist Church has been set for Sunday, it was announced this week by the Rev. Robert L. Bame, pastor. The church, located on Midland Road, is practically finished and will be officially opened January 6. Reason for the delay, church officials announced, is because some of the furniture has not arrived.

The final inspection of the church will be held tomorrow when the building committee, under the general chairmanship of Paul van Camp, and the official board, headed by J. A. Lourdermilk, meet jointly for a tour of the building.

As the good news was announced to the congregation, they were also reminded that the "mile of dollars" campaign, which seeks to raise funds to complete the church, is now in progress and will officially end

December 8. At that time it is hoped by the campaign committee that enough funds will have been raised to stretch play dollars from the Civic Club, where the congregation now meets, to the new building, a distance of approximately one mile.

If the mile of dollars is completed, the church will realize some \$10,000 in needed funds for the construction.
