Social Security

Many people in Moore County have difficulty in getting their social security check started because they cannot prove that they have reached retirement age, reports Thomas S. McDonald, Social Security representative for Moore County, because most births were not recorded in Moore County until 1920.

A birth certificate recorded at birth is the best proof of age available but since most people now reaching retirement age will not have this document, the Social Security Administration will accept other proofs.

The following is a list of some proofs which are acceptable to the Social Security Administration. They are in order of preference, and the older a document is, the more acceptable it is:

Birth certificate (recorded soon after birth,) baptismal certificate, signed statement by physician who was in attendance at birth, military record, passport, school record, insurance policy which shows age or date of birth, mar-riage record showing age or date of birth, age of parent on child's birth certificate, census record, statement of other person.

If you are nearing retirement age it will speed up your social security checks if, before you file your claim, you get one or more of the above proofs and bring them with you to the Social Security office.
