Bernard Dotson and four college friends from U.N.C. spent the weekend with his parents, the Rev. and Mrs. B. E. Dotson.

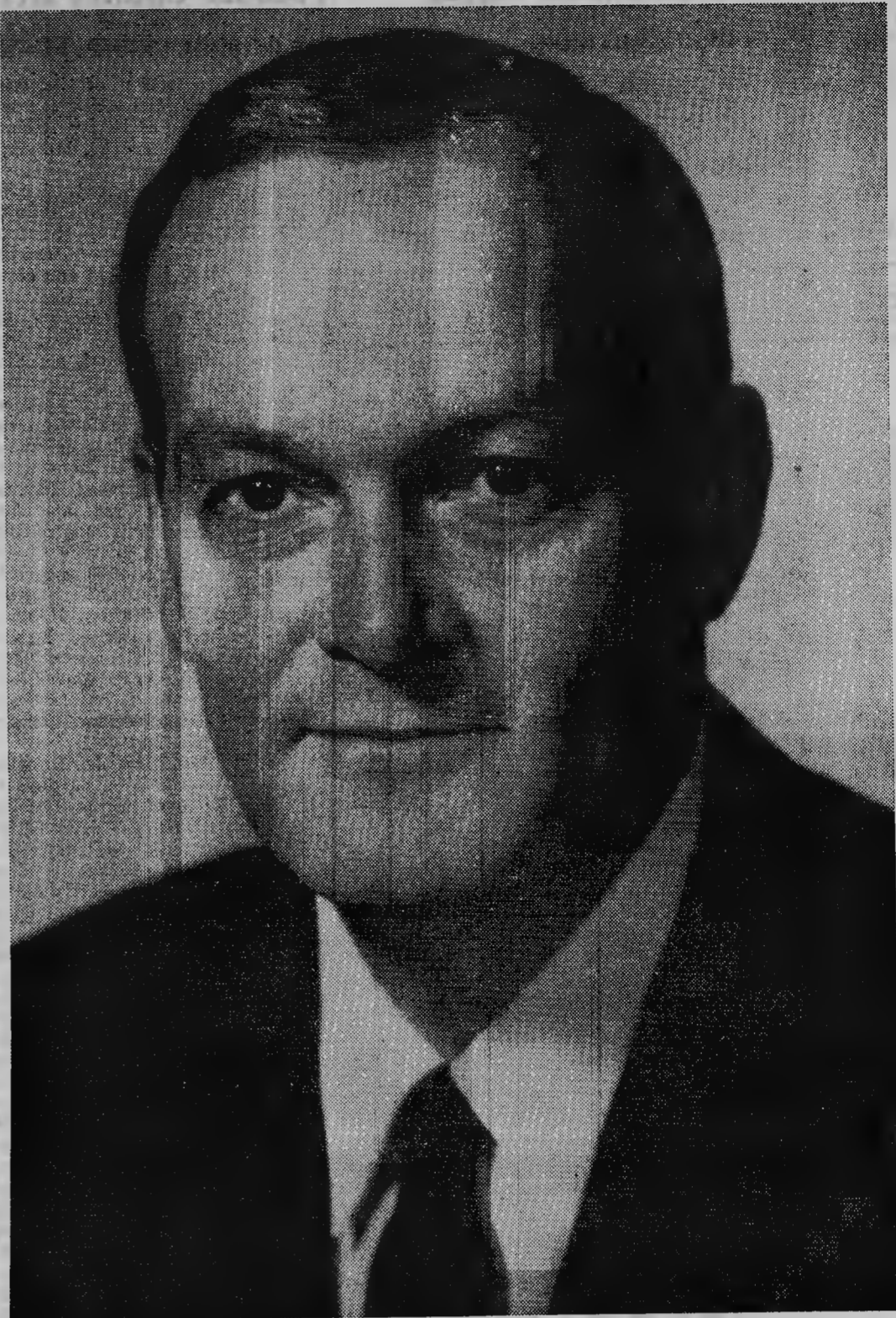
