Moore County Recorder's Court Has Long Session At Carthage, Monday

With two weeks of Superior Court intervening since the last sitting of Moore County Recorder's Court January 18, Monday's session ran long.

The docket consisted of more or less routine cases, as follows: Lenn Hobart Jackson, Sanford, Route 5, careless and reckless driving, 30 days or \$35 and costs; Bobby Lee Stutts, Carthage, speeding 50 in 35-mile zone, \$10 and costs; Cecil Earl Williams, Eagle Springs, Route 1, speeding 90 in 55-mile zone, 90 days suspended for two years on payment of \$75 and costs, defendant not to drive motor vehicle on public roads during next 12 months, not to violate speed laws, appeal noted and bond set at \$500; Charles Clifford Williamson, Robbins, Route 2, driving while drunk, 60 days or \$100 and costs, license revoked 12 months; Charles Junior Horner, Robbins, driving while drunk, 60 days or \$100 and costs, license revoked 12 months; Leon Eugene Davis, Robbins, Route 1, careless and reckless driving, accident, personal injury, \$30 and costs.

Frank Thompson, Jr., Robbins, driving while drunk, 60 days or \$100 and costs, license revoked 12 months; Freddie Calvin Ritter, Robbins, driving with improper registration, no insurance, 90 days suspended for two years on payment of \$35 and costs, not to operate motor vehicle during next two years nor till defendant has complied with all laws pertaining to licensing, registration and insurance; Daniel Leon Davis, alias Samuel Alfred Poole, Robbins, no operator's license (second offense) 30 days suspended for one year on payment of \$35 and costs, not to operate car till he first obtains proper license; Kenneth Lee Fry, Robbins Star Route, speeding 70 in 55-mile zone, \$15 and costs; James Ralph Smith, Carthage, Route 1, driving without license, judgment continued on payment of \$25 and costs; William Carl Fields, Carthage, speeding 55 in 45-mile zone, \$10 and costs; Truby Franklin Allred, Robbins, exceeding safe speed, \$10 and costs; George Leach, Vass, unlawful possession of illicit whiskey for sale, five months, 60-day suspended sentence invoked to run concurrently.

Michael Lewis Cockman, Southern Pines, speeding 65 in 55-mile zone, \$10 and costs; Ralph L. Hall, Star, public drunk, possession seal-broken whiskey, \$10 and costs; Eben Ray Davis, Seagrove, Route 2, driving after license revocation three months or \$200 and costs; Bobby Jean McDonald, Goldsboro, driving while drunk, 60 days or \$100 and costs, license revoked for 12 months; Russell Lee McKeithen, Vass, exceeding safe speed, careless and reckless driving, improper brakes, 90 days or \$25 and costs, pay damage to auto of Thomas Alford of West End amounting to \$212.51; Paul Arnold Brady, Carthage, Route 1, speeding 85 in 55-mile zone, 60 days or \$55 and costs; Raymond Owen Braddock, Carthage Star Route, careless and reckless driving, accident, personal injury, 60 days or \$25 and costs, pay medical and hospital expenses of those injured.

Felts, Claxton, Ga., speeding 50 in 45-mile zone, \$25 and costs; John Andrews, worthless check, judgement continued on payment of costs and amount of check; Frank Cowan, New Bern, escaping from prison camp, three months to be served at expiration of present term; John Henry Hunt, Randleman, escaping from prison camp, 60 days to be served at expiration of present term; Robert Wayne Riddle, Carthage, Route 1, careless and reckless driving, \$25 and costs; James Rufus Wooten, Carthage, abandonment and non-support of wife and two children, 60 days on roads; Larry Allred, Robbins, Route 2, aiding and abetting in speeding 90, allowing another to operate his car at 90, 60 days

suspended for two years on payment of \$50 and costs, not to drive motor vehicle during next 12 months, not to violate laws against speeding, reckless driving or drunken driving during next two years, and on additional counts of speeding 80 in 55-mile zone and improper registration, 60 days suspended on payment of \$55 and costs, defendant Allred gave notice of appeal and bond was set at \$250.

John Bibey, Carthage, Route 3, larceny of spray pump valued at \$65, 30 days to be served at expiration of 60-day suspended sentence now ordered into commitment; Devin Sheffield, Eagle Springs, Route 1, assault with deadly weapon, assault and battery, found guilty of simple assault, 30 days suspended on payment of costs and on further condition that defendant appear in court two weeks from today and show that he has made arrangement for the support of his wife; Lacy Lloyd Reeder, Star, driving while drunk, 60 days or \$100 and costs, license revoked 12 months; Russell Greene Smith, Jr., Carthage, driving after license revocation, judgement continued on payment of \$200 and costs; Robert Eugene Bennett, Sanford, Route 7, driving while drunk, not guilty.
