They resided on a farm near Selmi In February, 1929, Mr. Rose passed away suddenly. She with one little son was left to mour their loss.

Shortly before Christmas Mrs Rose started a course in Mrs. Hardbarger's secretarial school in Raleigh. She spent her week and at home and was ailing when she came home last Friday. On Saturday Drs. Person and Vice were called in and finding her condition quite serious sent he to Rex Hospital where an oper ation Sunday afternoon revealed peritonitis had already set in. Her condition was grave from the first and she sank rapidly until the end came Tuesday morning at four o'clock.

Mrs. Rose became a member o the Missionary Baptist church at an early age and remained faith ful and consistent to the end.

She leaves to mourn her demise her father, F. Kirby; a little son, Kirby aged 10; three sisters, Mrs. B. Fulghum and Miss Jennie Kirby of Selma, and Mrs. D. F Talton of St. Petersburg, Fla. Her brothers are: S. J. Kirby, Raleigh; P. H., Frank, Jim and C. P. Kirby of Selma.
