Applications received for amounts of \$1,000.00 to \$50,000.00, payable on the government amortization plan at 6 per cent interest, which means that the borrower pays \$35.00 semi-annually on the \$1,000.00, which is 6 per cent interest and 1 per cent of the principal, which retires the loan in about thirty three years.

The purpose and desire of the organizers of this bank are to eliminate the delays and dissatisfaction encountered in procuring a loan on real estate and to eliminate the red tape and reduce the expense of the borrower. Loans are made under the supervision of the local Board of Directors of Martin County Unit.

The Bank is organized under the auspices of the N. C. S. & Trust Co., of Williamston, N.
