GENERAL DAWES LETS CAT OUT OF BAG—

In a recent speech, Chas. G. Dawes, the running mate with Coolidge, denounced those men in Congress who claim the farmer ought to get better prices for cattle on the hoof, and that the consumer ought to get it for less on his table. Cattle on the hoof were selling then from five to seven cents a pound, and the consumer was paying 45 to 65 cents a pound for his beef on the table. This shows how plainly the public and cattle raiser are both being gouged by the beef trust, yet General Dawes says a man is a hypocrite who says that the farmer should get a better price for the cattle on the hoof, and at the same time allow the consumer to get it for less price on the table.

Last year when wheat was selling at such a distressingly low price a committee of wheat growers called on President Coolidge and set forth their grievances. The election being a long way off, more than a year of that time, he forgot the political game temporarily, and said "You should raise something else." How can a farmer who has been in the wheat raising business all his life with farming equipment for raising the same crop drop it instantly and go into some other business. This shows how much President Coolidge really cared for the farmer, and like all good Republicans, his first and foremost duty is to render obedient services to the magnates of Wall Street who buy the elections for the republicans who then permit Wall Street to get it back 10 times over out of the public.

Under Woodrow Wilson, the farmers of this country enjoyed the greatest prosperity they have ever enjoyed in our history. Not only was it true during the war but before the war broke out in Europe, farmers were getting \$1.33 per bushel for wheat. The Democratic party was the first to extend a helping hand to the farmers, and under President Wilson, the credit act went into effect, whereby the farmers borrowed money at a low rate of interest and thus prevented the forced sale of their crops at a low rate.

John W. Davis, who framed the farmers credit bill, has promised, if elected, he will give the farmers help from the national government whenever they need it.

DESERVES SUPPORT—

The Eastern Carolina Chamber of Commerce, with headquarters at Kinston, has announced the week of October 6th for an intensive section-wide membership campaign for this organization. A local committee in each of the forty six counties covered by this organization, will call on the business men and others with a view of enlisting their support in this campaign.

The Eastern Carolina Chamber of Commerce is nearing its third birthday and its record during the past two and half years, warrants the continued support of the people of Eastern Carolina. During this time it has made a place for itself in the development of this section and should have the united support of all the counties affected by its activities. There are many sectional problems that need just such an organization as this, and where there are so many counties in this territory that have no commercial organizations to help them locally, it makes it the more essential that there be an organization of this kind. The publicity that is being given Eastern North Carolina through this organization is worth many times the cost of the operation, aside from the fact that scores of projects have been put over and are now being put over by this sectional Chamber. We believe the people of Eastern Carolina should continue their support of this worthy organization.

STATE OWNED PORT AND HARBOR CONTROL PAYS IN CALIFORNIA

Most arguments involving harbor and port control in the North Carolina Shipping Bill which is to be voted upon by the people in the November election. Particularly the enemies of the measure claim that it will not pay and will be a dead loss to the people.

Justifying from the experience of the San Francisco port, it would be a big money maker for the State. The port of California made a net profit on its portion of one city above all expenses, upkeep, sinking fund and interest for the years 1910, \$467,893; in 1915, \$928,961 and in 1920 \$1,262,724, these being averages for ten years.

It is only a minor item however in the people of the state, and millions of dollars in lower freight rates. It might appear to some that if San Francisco is making such large sums from port and dock rentals, that it is charging exorbitant prices which is not true. San Francisco is giving the lowest rates of any Pacific port.

Every community that has built such a system has succeeded at least in two respects, paying for the investment in cash and in lower cost of freights.

Some of our people are saying that lower freight rates would not help the people but only the merchant. This argument is ridiculous, every one knows that the cost of goods is the base by which the merchant charges and freight is one of the big items in the cost of all merchandise today.

Any merchant will sell a barrel of flour cheaper with a twenty-five per cent reduction on the freight charges than he would had the freight charges been the same.

Another argument being put forth to prejudice the voters is that Williamston is the only place to be benefited. This can't be for the port commission is made up of good men scattered throughout the state, men who could be depended upon to make a proper distribution.
