

At the September, 1944, term, Martin entered a plea of guilty, and Martin was found guilty. Judge Leo Carr sentenced the two men to the roads for terms of two years. An appeal was noted by each of the men and the case went to the State Supreme Court for review. No error was found in the trial, but nothing was heard from the high court until last June. Judge Q. K. Nimocks, presiding over that term of court, sentenced the men to serve two years in State's Prison, but ordered execution of sentence delayed until the first day of the following September.

No other official records are to be **First of Examinations Slated** found, but attorneys had the sentence delayed until the December term to carry a plea for parole to the governor's office.

The plea for parole was advanced when the principal in the case, a Goldsboro doctor, was found not guilty in the Wayne Superior Court. It was reported at the time the doctor was placed on trial that at least one of the principal witnesses in the case was not called. 
