



Only One Farm Organization on Record for Flexible Support Plan

Contrary to claims that Secretary of Agriculture Ezra Taft Benson's farm program had strong support in all sections of the country, the following report coming out of Washington a few days ago tells a different story: How do the nation's farmers feel about the administration's


