THE NEW TREATY WITH MEXICO

The following is a copy of the new Treaty with the Republic of Mexico which was laid before the House of Representatives on Wednesday last by the President of the United States.

ARTICLE V. All the provisions of the eighth and ninth, sixteenth and seventeenth article of the treaty of Guadalupe Hidalgo shall apply to the territory ceded by the Mexican Republic in the first article of the present treaty.

ARTICLE VI. No grants of land within the territory ceded by the first article of this treaty, bearing date subsequent to the twenty-fifth day of September, when the Minister and subscriber to this treaty on the part of the United States proposed to the Government of Mexico to terminate the question of boundary, will be considered valid, or be recognized by the United States, or will any grants made previously be respected, or be considered as obligatory, which have not located and duly recorded the archives of Mexico.

ARTICLE VII. Should there at any future period (which God forbid) occur any disagreements between the two nations, which might lead to a rupture of their relations and reciprocal peace, they bind themselves in like manner to procure by every possible method the adjustment of every difference; and should they still in this manner not succeed, never will they proceed to a declaration of war without having previously paid attention to what has been set forth in article twenty-one of the treaty of Guadalupe for similar cases, which article, as well as the twenty-second, is here re-affirmed.

ARTICLE VIII. The Mexican Government having, on the 5th of February, 1853, authorized the early construction of a plank and railroad across the Isthmus of Tehuantepec, and to secure the stable benefits of said transitway to the persons and merchandise of the citizens of Mexico and the United States, it is stipulated that neither Government will interpose any obstacle to the transit of persons and merchandise of both nations; and at no time shall higher charges be made on the transit of persons and property of citizens of the United States than may be made on the persons and property of other foreign nations; nor shall any interest in said transitway, nor its proceeds thereof, be transferred to any foreign Government.

ARTICLE IX. The United States, by its agents, shall have the right to transport across the Isthmus, in closed barges, the mails of the United States, not intended for distribution along the line of communication; also, the effects of the United States Government and its citizens, which may be intended for transit, free of custom-house or other charges by the Mexican Government. Neither passports nor letters of security will be required of persons crossing the isthmus and not remaining in the country.

ARTICLE X. This treaty shall be ratified and the respective ratifications shall be exchanged at the city of Washington, within the exact period of six months from the date of its signature, or sooner if possible.

ARTICLE XI. In testimony whereof, we, the plenipotentiaries of the contracting parties, have hereunto affixed our hands and seals at Mexico, in the year of our Lord one thousand eight hundred and fifty-three, in the thirtieth year of the independence of the Mexican Republic and the seventy-eighth of that of the United States.

ARTICLE XII. The provisions of the sixth and seventh articles of the treaty of Guadalupe Hidalgo having been rendered nugatory for the most part by the cession of territory granted in the first article of this treaty, the said articles are hereby abrogated and annulled, and the provisions as herein expressed substituted therefor.

ARTICLE XIII. In consideration of the foregoing stipulations, the Government of the United States agrees to pay to the Government of Mexico, in the city of New York, the sum of ten millions of dollars, of which seven millions shall be paid immediately upon the exchange of the ratifications of this treaty, and the remaining three millions as soon as the boundary line shall be surveyed, marked, and established.
