Notice is hereby given (in accordance with section 18 of the Machinery Act) to all persons in this county required to list property or poll for taxation, must list their taxes during the month of May. The following are the list takers for the various townships:

After May 31st the tax lists will be closed. Attention is also call to the fact that  
FAILING TO LIST WILL RESULT IN YOUR BEING SEVERELY PENALIZED

You are required by law to meet the list taker at the above named places and list all real and personal property. Please do not fail to list your taxes before expiration of time limit. Be prepared to make your farm report as required by law.

It is especially urged that property be listed as early as possible, and owners not wait until the last minute, so that the listers may have sufficient time in which to properly execute the blanks.
