"We did not call on a single local merchant who failed to cooperate with us to the fullest extent while our calls on the chain stores were failures."

ASKS FOR APPROPRIATION INVESTIGATE BEEF CATTLE

Washington, D. C. - Congressman Lindsay C. Warren of North Carolina recently headed a large delegation of members of Congress from the states of Virginia, North Carolina, South Carolina, Georgia, Alabama and Florida in an appearance before the Appropriations Committee asking for an appropriation of \$100,000 to investigate beef cattle and related livestock problems in the area recently released from cattle tick quarantine. If federal funds are secured it will be on a fifty-fifty basis with the six states affected.

Mr. Warren pointed out to the committee that since the eradication of the cattle tick, there are 1,307,000 fewer cattle in the six states than there were five years ago, and that the value had decreased 20 percent. He cited the agricultural transition now going on in North Carolina and other Southern states and praised the agricultural leadership of Governor Gardner, Clarence Poe, and Fred P. Latham. He was followed by other southern congressmen who strongly endorsed the appropriation. Representatives Clark and Abernathy were the other North Carolina speakers. The delegation felt that they made a good impression on the committee, and are hopeful of results.

To send invitations to each of our farmers, manufacturers, cleaners and shellers is almost out of the question, but we feel with the aid of a representative group of our peanut people throughout the section we should be able to make a showing. Along with our individual efforts we propose to use the press for all it is worth in bringing this meeting to the attention of everyone in the territory and in every way possible impress upon them the importance of the meeting.

TO SPEND \$200,000 ON SURVEY ROANOKE RIVER VIEW TO CONTROL FLOODS

The United States Government will spend the sum of \$200,000 for a survey and investigation of Roanoke river with the view of controlling its floods and investigating its water power possibilities, according to Congressman Lindsey Warren, who was today notified by the Board of Engineers that they had approved the preliminary report of Major W. A. Snow, District Engineer, and had sent the matter back to him for a complete project study. The investigation will require many months.

After his next report, if still favorable, Congress will be called on to appropriate many million of dollars for the work. Mr. Warren stated that this was in addition to the navigation project for Roanoke river which will be included in the Rivers and Harbors bill.

The preliminary report for the flood control of Tar river was unfavorable, but Mr. Warren today requested the Chief of Engineers to send it back to Major Snow for further investigation, as a disastrous flood has occurred since he filled his report. Congressman Warren requested that public hearings be had on this newly discovered evidence at Rocky Mount and Greenville.

The bills for the flood control of Roanoke and Tar rivers were introduced by Mr. Warren three years ago and passed by Congress. Congressman John H. Kerr, through whose district both rivers also run, is actively interested and rendering full co-operation. Excessive and unprecedented floods of the two rivers have made farming along their bank quite precarious. The expenditure of \$2,000,000 for investigation alone of Roanoke river is one of the largest appropriations for that purpose on any southern rivers, and naturally Mr. Warren is quite pleased.

TELLS OF MAKING GOOD AFTER MAKING MANY FAILURES IN TOMATOES

When Miss Covington, our Home Demonstration Agent asked the members of the Hoke Club if we would not try to raise some tomatoes for market, I readily told her that I would be glad to plant some tomatoes if I could raise them, but as I had failed repeatedly to even raise enough for home use on account of wilt. I felt like it would be throwing my time away to bother with them.

Miss Covington said probably if I would plant the wilt resistant kind that I could raise some. So she talked with Mr. Dunning, our farm agent, about it and he advised me to try the wilt resistant kind. Miss Covington ordered the seed for me. I planted them and they came up fine, and such growing I never saw. I just could not get those plants set out until they were as much as 18 inches high, but they went right off to growing.

I only had them plowed once. On account of the heavy rains, they became awfully grassy, but I cleaned the grass out and did not bother them any more until I commenced gathering tomatoes in early September.

I have never seen so many tomatoes nor such nice ones. I set six rows, 60 yards long and did not have a single plant to have the wilt. Below you will find a statement of what the six rows brought me as near as I can get it:
