Agent Expecting Increased NEGRO KILLED NEAR DARDENS

COUNTY CONVICT PURLOINS CAR **Tobacco** Acreage in County AND RUNS AMUCK

Ran Over Negro Man and Wrecks Car in Edenton Saturday

Charley Alexander, trusty at the county prison farm near here, drove an automobile wildly through the streets of Edenton last Saturday afternoon, ran over a negro man, breaking both legs, crashed into two automobiles and a tree, and then fled to freedom in a stolen car. He was captured later Saturday, night at the home of his father, Charles Alexander, and placed in the Edenton jail on a charge of escape. He was to have been heard in recorder's court there Tuesday, but the case was postponed until next week. Although bruised considerably in the crash into th tree, he was not seriously injured.

Alexander had been taken to Edenton by W. C. Spruill, a guard at the prison camp, in order that the convict might see his parents. Before reaching Alexander's home, Spruill had to stop in Edenton on an errand, and left the convict in the automobile

Alexander is then alleged to have driven to a bootlegger's place and loaded up with whisky. Then he went on a rampage, colliding with two automobiles and running down the negro. He finally wrecked the guard's car by running into a tree. The prisoner then confiscated another car and drove in the direction of Windsor. That was the last seen of him until he drove to his home in the stolen car.

Following is the scale of prices offered by the canning plant operator for this year: From June 10 to June FRIDAY NIGHT 20, 5 cents per basket for green tomatoes; from June 20 to July 4, 30 Order Sale of Property for from July 4 to July 12, green tomacents per basket for green tomatoes; toes, 25 cents per basket; ripe tomatoes, from June 10 to July 4, 25 cents per basket; and all green and ripe tomatoes, from July 12 for balance of


