INDUSTRY IS SELF-CONVICTED

Both Senators Are Conservatives In Matter of Government Ownership But Disgusted With Situation.

New York.-United States Senators William Calder and W. E. Edge, members of the senate committee on reconstruction, in a joint statement announced that "unless the coal industry reforms itself and cuts prices to a reasonable figure by December 6th, they will introduce a bill for the most stringent regulation of every branch of the business."


The senators declare they do not undertake to say "that this individual is a profiteer and that this one is not, but the coal industry as a whole stands self-convicted of practicing gross extortion on the whole public of the United States."

"We are both opposed to government regulation as a policy," the statement said, "but the government must assume responsibility for its people, and we will recommend a bill for entire control of the industry just as far as possible under the constitution unless prices are materially

reduced to the public by December 6. "We are deadly in earnest about this. We are both conservatives on the matter of government ownership, but we are absolutely disgusted with this situation.
