The Tarheel State's share will feed, clothe and educate 3,334 innocent wer victims, now in North Carolina orphanages at Trebisond, for each year. So efficient is the work of the national Near East Relief that each child can be fed, clothed and educated on \$5 a month

In announcing postponement of the drive in this country Colonel Bellamy declared that this is a call that North Carolina cannot turn down, because the life of many of our own boys in the world war was saved by the sacrifices made by Armenian troops whose children we are now supporting.

"Armenia's" heroic defense of the Baku oil fields shortened the war by many months, according to all experts," Colonel Bellamy declared, "because by a superb sacrifice of their own lives by 300,000 of Armenia's 400,troops, they prevented the German drive on Baku from accomplishing its purpose.

"There is many a North Carolina boy back home today who would now be sleeping under a wooden cross in France had the war been continued, because they were killing men off at the rate of 10,000 a day when the war ended. North Carolina cannot see the children of these heroes starve or freeze to death."

Others of these children were made destitute when their parents were murdered for refusing to renounce Christ and become Mohammedans during the Turkish depredations into Armenia in the name of Mohammedanism.
