TEXTILE STRIKES ARE NEARING THE END.

Judging from the way things are going, the strikes in the cotton mills of the South are nearing the end.

Let it have been the most effective protest ever made by the cotton mill workers, and they have made a tremendous gain.

And one other something, as Brevard often prefaces his remarks—the Chambers of Commerce in the South will stop their very foolish practice of the past in advertising to the world that we have "cheap" labor in the South.

So when the men and women and boys and girls return to their work, do not make the mistake of saying those workers lost their strike.
