Democrats and Cold Water

Houston, Tex., May 21.—Cold water may prove a deciding factor in the selection of a Democratic nominee for the presidency in case the delegates drift into a convention deadlock and are compelled to sit through long drawn out balloting in the heat of Texas midsummer.

There being no such thing as a frost line in this latitude, water mains in Houston are laid close to the top of the ground. As a result drinking water taken direct from the tap has a temperature of 85 degrees—considerably too warm for the average politician. For this reason, the city of Houston has turned over the convention drinking water problem to engineers.

Automatic electric coolers, equipped with oversized Frigidaire motors will be scattered about the convention floor and set up outside the hall, for the relief of hot and thirsty delegates, many of whom will be experiencing the heat and humidity of southern Texas for the first time.

Refrigeration engineers, who have been assigned to the task of chilling the convention water supply will install mechanical equipment that has been tested in the blistering heat of steel mills, where a cake of ice disappears like a slice of butter on hot toast. Water coolers that have performed successfully in the full glare of open hearth furnaces will function for the Democratic delegates until some one gets the necessary two-thirds vote.

It is estimated that the automatic water coolers will provide the cooling equivalent of nine tons of melting ice daily, making it easier for organization leaders to hold their delegates in line in the event the convention fails to arrive at an early choice. This will give each delegate the equivalent of 15 pounds of ice daily for his drinking water as long as the convention is in progress.

1. The Poplar Cove School in Cartoogechay township to and from the Slagle school for six months.

2. One bus to operate from a point one-half mile south of Mulberry school house to and from the Franklin graded school.

3. One bus to operate from a point on the highway opposite Riverside Ry. Station to and from Franklin graded school.

4. One bus to operate from Iotla school house to and from Franklin graded school.

5. One bus to operate from Morgan's store to and from Franklin graded school.

Contractors will be required to furnish comfortable buses and on routes 2, 3, 4, and 5 the minimum capacity must not be under 30 high school pupils. These routes will be operated for nine months, provided the average number transported does not fall below 20. Route 4 will be required to operate from Iotla school house when roads are safe to that point, otherwise to the Iotla bridge. Route 5 will operate to Morgan's store when the road from the highway to the store is safe for school bus travel, otherwise to the bridge near the home of H. D. Dean. Each contractor will be required to furnish a bond in the sum of \$200 to guarantee the faithful compliance with the terms of the contract. No bid will be considered unless a bond is submitted with it. The Board reserves the right to reject any or all bids. All bids and bonds must be in the hands of the County Superintendent of Schools not later than 10 o'clock, Monday, June 4, 1928.
