Revival at Campbellton.

Cumberland Court.

Notwithstanding the dreadfully hot weather the work of the court goes smoothly on, and when night comes those who have been actors on the scene—the Judge who has to keep his head cool, the lawyers who have to brow beat and plead alternately, the witnesses who have to remain placid under a storm of entangling questions, the jury who have to be locked up in a close room to consult, and finally the sheriff and his officers who have to be constantly running about shouting "order in court," and looking after witnesses and prisoners—wonder how they survived it all.
