In Indiana.

Hon. William J. Bryan opened his Indiana campaign yesterday in Richmond where he spoke to three large audiences. He spoke at numerous other places to immense crowds and ended the day by delivering three speeches at Fort Wayne, one of which was addressed to twenty thousand people. The enthusiasm was rampant wherever he appeared.

"Guiltier of the Two."

This morning's Raleigh News and Observer says that, at the hearing before Justice Clark of the case of the lost registration book in that city, (referred to elsewhere in this issue), the general verdict of the audience was that Britt, the so called Populist registrar, was guiltier than the negro registrar.

On Election Night.

The election returns will be received in the Armory Tuesday night, November 3d. The managers of the Army have made arrangements with the Postal-Cable and Western Union Telegraph companies to run their wires into the building and receive the messages from their respective headquarters. Thus both companies will give news from different parts of the country at the same time.

The telegrams will be read as soon as received from the stage. A small charge possibly 25 cents, will be made for admittance to the armory.

Candidates at Manchester.

The County candidates of all parties and of no party, twenty odd in number, addressed a gathering of fifty voters at Manchester yesterday. Three fourths of the audience was composed of colored men, who listened attentively, but displayed no enthusiasm at all, not even when their white republican bosses waved the red flag in their faces. For the first time since they opened the campaign the candidates indulged in a joint discussion, each speaker being allowed 20 minutes. The time of each was mostly taken up in explaining "where he was at," and so the debate did not wax warm at all. It was simply a preliminary to the great battles that may be expected to make the county ring with partisan cries, from Mink's Creek to Chicken Swamp, from now until the day of election. But all joking aside, there are a number of good speakers among the candidates, and things will no doubt be interesting from now on.
