The infection with hookworm disease in this county was much below the average as only 8% of those examined had the disease. More were found to have the other varieties of intestinal parasites, however, as 37% were infected with these.

The lack of infection with the hookworm disease was certainly not due to good sanitary surround ings of the houses.

The towns have few other than the open back privies. A majority of the country homes have none. Marshall, the County Seat, is ideally situated for a sewerage system. The town containing the Court house should be an example in sanitation for the others to follow. Typhoid Fever should be unknown. That is in itselfs disgrace to any community. Hot Springs is far ahead of Marshall along this line. Here a majority of the houses have closets connected with a sewerage system which empties into the river below the city. Still even here there are many improvements yet to be

The sanitary condition of Walnut is poor. Only the ordinary open back privies are used. The water supply is very scant, as well.


