



## **Questionnaire Form Will Be** Available To Citizens Age 17 And Up

Madison County is taking a step forward for industrial expansion and general economic development with the beginning of a labor survey that is to be conducted by the Madison County Planning Board with the cooperation of the Bureau of Employment Security Research of the Employment Securi-

ty Commission of North Carolina. The type of information gained from a labor survey is essential for a successful industrial or economic development program. Many counties of the State have previously made such surveys and have been using the resulting statistics to attract new industries, to develop recreational and tourist facilities, and serve local industries considering expansion.

A survey was conducted in Madison County several years ago when Hammarlund Manufacturing Company of Mars Hill was considering the area for plant location. The present survey will cover all of Madison County and portions of Yancey County and Buncombe County that are in commuting distance to Mars Hill,
