

#### NEW FEE LAW.

An act relative to probate and registration fees of Harnett County. The General Assembly of North

Carolina do enact: Section 1. That the fees charged for registration of real estate transform in Harmett County shall be in-crossed twenty-five conts each, and chattel mortgages ten cents each over present charges; and the fees charged by the Clerk of the Court for probating real estate transfers shall be increased from twenty-five cents to fifty conts, and chattel mortgages from ten cents to twenty conts. Sec. 1. That all inve and clauses of laws in condict with this set are hereby repealed. Sec. 3. That this set shall be in force from and after its ratification. 
