SUNDAY SCHOOL JUNE 11

Lessons from Jeremiah's Character. Jeremiah 28:4-15.

Golden Text: Be not afraid of their faces; for I am with thee to deliver thee, saith the Lord. Jer. 1:8.

Here we have the secret of Jeremiah's stability. He had the assurance given in our Golden Text that God, whom he trusted, would sustain him. With this assurance he faced difficulties that would have appalled a man with less faith and its attendant courage. At the time of the events recorded in our lesson he seems to have become disgusted with the disobedience and general attitude of indifference toward God in Jerusalem and to have decided to leave there and join the tribe of Benjamin in the North, not that his faith in God was less, or his fears for his personal safety greater, but he saw the utter uselessness of trying longer to overcome Judah's apparent determination to have her own way in spite of his warning. The army of Pharaoh was approaching; that of Nebuchadnezzar was retreating from before the city. Zedekiah, still believing the lies of the prophets who professed to please him, was looking to Egypt for help. God had commanded him, through Jeremiah, to submit to bondage under the Babylonian government and had promised immunity from destruction or removal from the homeland. Zedekiah ignored God's word and followed a man of his own.
