### Sunday—The Day of Acclaim

HIGHLIGHTS ON THE SUNDAY SCHOOL LESSON 5/2

By NEWMAN CAMPBELL (The International Uniform Lesson on the above topic for May 3 is Mark 11:1-11; Luke 19:41-44, the Golden Text being Mark 11:9. "Blessed is he that cometh in the name of the Lord.")

THERE IS something especially delightful to us who follow Christ's life on earth, about His triumphant entry into Jerusalem. It is as if a dear earthly friend, who has had a hard struggle, finally has a wonderful happiness and triumph; is acclaimed by all for his superior qualities and achievements. Even though he may suffer later, we share with him the joy of this day.

It is not a day of unmitigated joy for our Lord. Before the journey is ended He weeps over Jerusalem. But it is a happy day, nevertheless, for at the end, we are told, He went back to Bethany, and to the home of His dear friends, Martha, Mary and Lazarus.

It is told that when Christ and His disciples neared Jerusalem, near also to Bethany and Bethphage, He called two of His disciples and told them to go to the next village, where they would find a young colt tied that had never been ridden by a human being. The colt was an ass, a staller, livelier, swifter animal than ours, and one on which kings and princes rode.

The Lord's Need Enough They were to untie this colt and bring him to Jesus. If anyone asked them why they were taking him, they would answer, "The Lord hath need of him," and no one would interfere. The two did as they were asked, found the colt tethered to his master's house, and brought him to Jesus. Some did ask why they loosed him, but when they gave Jesus' answer, they were allowed to take him.

When the disciples brought the animal to Jesus, they put their garments on him and Jesus mounted. Others spread their outer wraps in front of Him and still others cut down palm branches and strewed them in His path, and a great procession started toward Jerusalem, the people shouting with joy and singing, "Hosanna; blessed is He that cometh in the name of the Lord: Blessed be the kingdom of our father David, that cometh in the name of the Lord."

Thus triumphantly Jesus entered into Jerusalem a few short days before the time He was to suffer arrest and humiliations, scourgings, etc., and a terrible death, deserted by His friends. Entering the temple at Jerusalem He looked about, and then, as even time had come, "He went out to Bethany with the twelve."

St. Luke tells of the one incident in the Saviour's progress that is not a happy one. As they descended the Mount of Olives toward the city, St. Luke says:

"He beheld the city, and wept over it, saying, If thou hadst known, even thou, at least in this thy day, the things which belong unto thy peace! but now they are hid from thine eyes.

"For the days shall come upon thee, that thine enemies shall cast a trench about thee, and compass thee round, and keep thee in on every side.

"And shall lay thee even with the ground, and thy children within thee; and they shall not leave in thee one stone upon another; because thou knewest not the time of thy visitation."

Prophecy Fulfilled Forty years later the prophecy was fulfilled, under Titus, the Roman general. The city was destroyed, made an utter ruin, one stone not being left upon another. The inhabitants were all slain. Seeing this would come, the Master wept.

Nevertheless He and His disciples, surrounded by a happy, shouting multitude, entered the city, and went to the temple, where Jesus looked about Him, and as it grew late, He and His friends went to Bethany where they were sure of a welcome.

This was on Sunday—Palm Sunday we call it—and the Thursday following Jesus spent in the Garden of Gethsemane, in great grief and anguish of spirit, and Friday He was crucified. The powers of evil had their way for a little time, but Right triumphed in the end. The Romans and rulers of the temple thought they had put out of the world a dangerous person, one whom they feared and hence hated. But where are they today? Who knows their names and where they lie? While all the Christian world worships and bows down before the Savior, Jesus Christ.

## Absentee Ballots

For PRIMARY ELECTION

TO BE USED ONLY BY MEN IN ARMED FORCES

1. No one is entitled to vote by absentee ballot in a primary election who is not a member of the armed forces of the United States.
2. The application for the ballot must be in writing, signed by the voter or in his name, by his wife, brother, sister, parent or child.
3. The application must state the precinct in which the applicant is a qualified voter and must show the company or other armed unit of which he is a member.
4. The written application must be filed with the Chairman of the County Board of Elections and must be kept on file by such Chairman.
5. Upon receiving an application, the Chairman must enter the name of the applicant on a register kept for that purpose, the name, party, address and precinct of the applicant. Such register is a public record, open at all times for inspection by any voter of the County.
6. After registering the application, the Chairman shall deliver to the applicant, after having signed the certificate on back of the ballot, an official ballot of the applicant's precinct. NOTE: This ballot cannot be delivered to any person whomsoever, as agent for the voter but must be mailed by the Chairman to the voter himself.
7. The chairman must send with the ballot an envelope for return of the ballot, addressed to the Chairman sending and having printed thereon the certificate set out in this statute.
8. The Chairman, on the day of the primary, and not before, must deliver, or cause to be delivered, to the appropriate precinct, all ballots, with envelopes unopened and the seals broken, which have been returned to him.

The above 8 rules and regulations have been sent to you by the State Board of Elections and will be strictly adhered to in all and every instance.
