Entering the Promised Land

HIGHLIGHTS ON THE SUNDAY SCHOOL LESSON

(The International Uniform Lesson on the above topic for July 2 is Joshua 1-6, 23, 24, the Golden Text being Joshua 1:9, "Be strong and of good courage; be not afraid, neither be thou dismayed: for Jehovah thy God is with thee whithersoever thou goest.")

IT IS thought that the events chronicled in this very long lesson occurred around 1400 to 1375 B. C., or thereabouts. The first events are located on the east side of the river Jordan; the rest on the west side. Joshua died at Echechem.

After the death of Moses the Lord appointed Joshua, son of Nun, to lead the people of Israel into the land He had promised them. He told Joshua of the great lands they were to take for their homeland and it may be mentioned that never, even in the time of Israel's greatest glory, was all this land inhabited by them.

First, Joshua chose two men to go to Jericho and spy secretly. They went to the house of a woman named Rahab, but the two must have been seen entering her house because men came there at night to arrest them. Rahab, however, hid them on her roof under long stalks of drying flax, so that the men did not find them, and after they had left she let them down the wall with ropes, through a window, as her house was built on the city wall.

Jericho Afraid

She told them that all the city had heard how God caused the Red sea to part for their crossing and all Jericho was afraid. She asked them to spare the lives of herself and all her kin for this great favor. They promised, and told her to bind a line of scarlet thread in the window and bring all her relatives to live with her. The two men hid in the mountains for three days until the pursuers gave up the search, then returned to Joshua.

Next day the children of Israel began their march across the Jordan with the ark of the covenant leading the way. The waters of the Jordan parted, as Joshua had said, and they passed over in safety. Joshua chose a man from each tribe and told each to take a stone from the bed of the river where the priests' feet had stood and bring them to him. And Joshua set them up as a memo-

rial of the Lord's goodness. Now all the people inhabiting the lands that had been promised to the Israelites were afraid because of the reputation of the children of Israel, and the city of Jericho was shut up tight, no one leaving and no one going in. The Lord told Joshua to send seven priests with trumpets ahead of the ark of the Lord, and armed men were to go before and behind, and they were to march around the city walls blowing trumpets. Seven days they marched around the city, blowing their horns, and on the seventh day the trumpets blew and the people all shouted and the walls came tumbling down.

All the inhabitants were put to the sword except Rahab and her people, and the city was burned, but the silver and gold, vessels of brass and iron, were put into the treasury of the house of the Lord.

Joshua Grows Old

A long time after these events, the Lord gave Israel a rest from their enemies. Joshua had grown old and feeble and knew that his time was almost gone. He called for all Israel and for their elders, and for their heads, and for their judges, and for their officers, and told them that he would not be with them much longer. He reminded them of all the mercies the Lord had vouchsafed them, and warned them not to serve the false gods of the people among whom they dwelt, but to cleave to their own God.

"For the Lord hath driven out from before you great nations and strong; but as for you, no man hath been able to stand before you until this day.

"One man of you shall chase a thousand; for the Lord our God, He is that fighteth for you, and He hath promised you.

"Take heed, therefore, unto yourselves, that ye love the Lord your God."

The people were told to choose whom they would serve, whether the gods of strangers or their own God, "but as for me and my house, we will serve the Lord," said Joshua.

And all the people answered and said, "God forbid that we should forsake the Lord, to serve other gods."

"And Israel served the Lord all the days of Joshua and all the days of the elders that overlived Joshua, and which had known all the works of the Lord, that He had done for Israel."

Sgt. Chambers Given Award For Bombing Enemy.

An Eighth AAF Bomber Station, England—Staff Sergeant James W. Chambers, 25, of Clyde, waist gunner on an Eighth AAF Flying Fortress, has been awarded an Oak Leaf Cluster to his Air Medal, equivalent to another award of the Medal.

The award was for meritorious achievement while participating in bombing attacks on targets in Europe.

Sgt. Chambers is the son of Mrs. Margaret Chambers of Clyde. He was an electrician with the American Enka Corporation before he entered the AAF Sept. 20, 1942.
