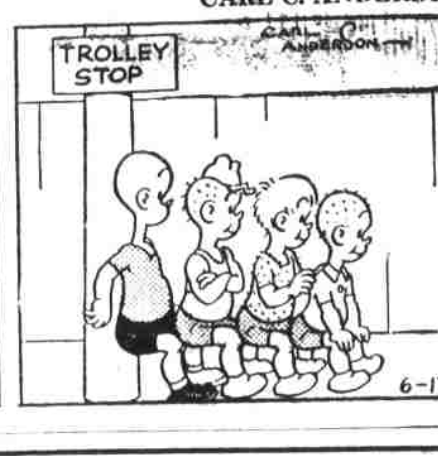
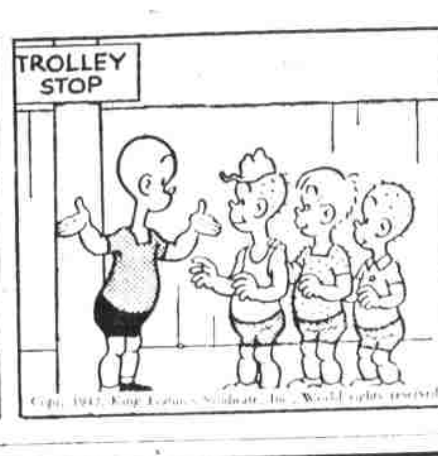
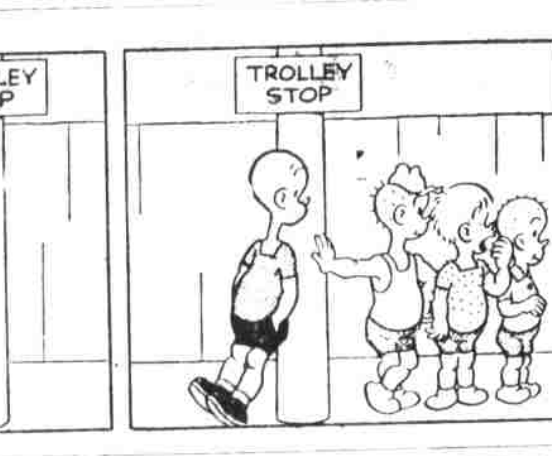
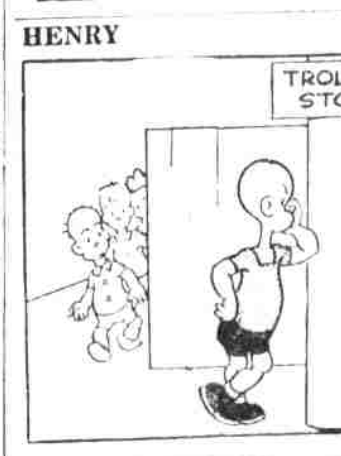
STATE OF NORTH CAROLINA COUNTY OF BUNCOMBE
