REPEAL OF CON-FLICTING ORDINANCES: All ordinances and parts of ordinances inconsistent with the terms of this ordinance are hereby repealed; provided, however, that such repeal shall be only to the extent of such inconsistency and in all other respects this ordinance shall be cumulative of other ordinances regulating and governing the subject matter covered by this ordinance.

Section 14. SEVERABILITY: If any section or provisions or parts thereof in this ordinance shall be adjudged invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the validity of the ordinance as a whole or of any other section or provision or part hereof.

Section 15. EXERCISE OF PO-LICE POWER: This entire ordinance shall be deemed and construed to be an exercise of the police power of the Town of Waynesville, in the State of North Carolina for the preservation and protection of pubic safety, and all of its provisions shall be liberally construed with a view to the effectuation of such purpose.

Section 16. EFFECTIVE DATE: This ordinance shall be in full force and effect from and after its passage and publication as required by law.
