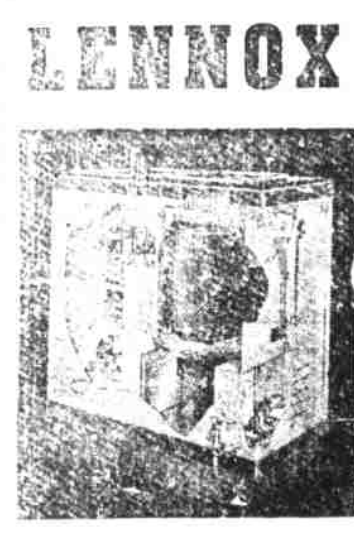

SEATTLE (AP) - Naval reservists from the 10th Naval District this summer will have an opportunity to find out what is on the "top of the world" during the Navy's expedition to Point Barrow, Alaska.

Point Barrow, in the Arctic Circle, is the land where "lights and days are six months long" where the walrus and the polar bear hold forth, where the Eskimo missionary and a scattering of whites live throughout the year.

The Point will be a base for the Navy's Arctic oil fields and weather stations. During 11 months of the year, it is frozen.

The Navy's expedition this year will consist of from three to five Navy cargo vessels, two LST's and an ice breaker. The party will leave San Diego June 20 and return Aug. 25.
