Arkansas Town Becomes Midwest Gretna Green

JOPLIN, Mo. (UP)—The marriage center of the four-state area of Missouri, Kansas, Oklahoma and Arkansas has moved from Columbus, Kan., to Bentonville, Ark. Missouri and Oklahoma have had marriage license waiting periods and blood test laws for some time. Kansas enacted such a law in 1947. Until the Kansas law was enacted, couples converged on Columbus, Kan., where they could get married without waiting. Hundreds of Missouri and Oklahoma couples said "I do" in the Columbus court house. Now, Bentonville is the Gretna Green of the midwest as Missouri, Kansas and Oklahoma couples go to Arkansas for a quick license.

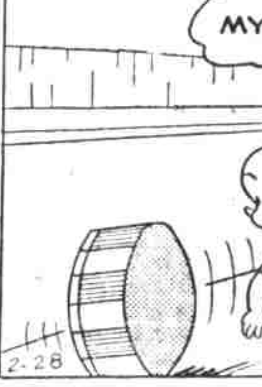

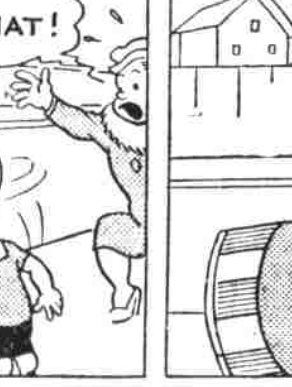
