INSURANCE, The government's acted into law on the final day of the 84th Congress, provides ways and means for you to insure any personal or real property against water damage from hurricanes and other natural disasters.

The law provides for government insurance up to \$10,000 per dwelling unit, and a maximum of \$250,000 for any one person, which would include business property and the like






