

Mobley is alleged to have killed as wife, Mrs. Evelyne Mobley, at their home on July 24. After allegedly shooting his wife, Mobley turn-ed the 32, caliber pistol on himself. e of the two bullets fired entered his jaw and the other entered his chest and lodged behind his left shoulder blade.

He was confined at Duplin Gen-Hospital for several weeks under 24-hour guard until ordered to Raleigh for sanity tests at Dix Hill, according to Sheriff Miller.




