## Cornerstone Laid



## New Hospital Cornerstone Laid

Chapel Hill — Cornerstone laying ceremonies for the new 400-bed teaching hospital at the University of North Carolina were held Wednesday afternoon. The ceremony was held according to Masonic rites with North Carolina Grand Master of Masons, Wallace Caldwell, in command.

A procession of those participating in the program formed in front of the old Medical Building at 3:30 o'clock and marched to the new structure where a platform had been set up for the speakers. Brief addresses were given by Governor W. Kerr Scott, Dr. L. P. McLendon, Greensboro, chairman of the Trustees Committee of the Medical School; Assistant Gordon Gray; William Umstead, Durham; Kay Kyser, Chapel Hill and Dr. Paul F. Whelan, Kinston.

Taking part in the Masonic rites were Collier Cobb, Jr., Chapel Hill, chairman of the Trustees Building Committee; a representative of the architects; Herbert M. Foy, assistant Airy, deputy Grand Master; Liam L. White, Sanford, senior and Warden; Edwin Howard, High Point, junior Grand Warden; and Vance, Asheville, Grand Marshal; J. Glenn Blackburn, Lake Forest, Grand Chaplain. Attending were a number of Masons present for the annual communication here.

Others participating in the program were: Dr. W. Reece Berry, dean of the Medical School; Robert R. Cadmus, administrator of the Hospital; Dr. Henry Clark, Jr., administrator of the Division of Health Affairs, Dean G. McGavran, of the School of Public Health; Dean John C. Bauer of the School of Dentistry; Elizabeth L. Kemble of the School of Nursing, and Dean E. Brecht of the School of Pharmacy.

The new teaching hospital, which is a part of the state-wide health program, adds another 400 beds to the 9,000 that are needed in the state five years hence. Since that time it is reported that the need has been reduced 50 percent by hospital construction under the new program. The building is scheduled for completion in January and the opening set for next April.

## County Spellers to Compete Here for Lions Medal

Chapel Hill — A county-wide spelling contest will be held Friday, at the Agricultural Building at 1:30 o'clock, it was announced today.

The winner of the local contest will be presented a medal by the Hillsboro Lions Club, which voted last week to sponsor the contest annually. The state contest is to be held in Winston-Salem soon.

Hillsboro — A playlet, song and dance routines, choral music, a monologue and band numbers will be featured in the Home Talent Show to be presented tomorrow night at 8 o'clock at the Hillsboro High School Auditorium under the sponsorship of the local Lion's Club and Parent-Teacher Association.

Proceeds from the show, which is expected to be about two hours long, will go toward paying for curtains for the auditorium stage.

The seventh grade room of Mrs. Elmer Dowdy will present a playlet entitled "Mountain Music." Miss Maude McCauley's third grade will put on a song and dance routine. Under Mrs. Helen Warren, the eighth grade choral group will sing several numbers, and the High School band and glee club, under the direction of Jim Rittenhouse, will take part in the show.

## Little Chance Of Escaping Security Report

Hillsboro — Orange County housewives, who have been employing part-time servants, learned this week that they have very little chance of escaping the new social security report and tax payments for household servants.

According to the first reports issued by the government, only those servants who were paid \$50 or more in cash in a calendar quarter (January, February, March, for instance), were to come under the new social security law. This left out those who worked a half-day twice a week at 50c an hour or worked for 40c an hour three half-days a week.

An explanation of the law issued this week however, points out that servants who worked at least 24 different days or part days, regardless of the number of hours in a quarter, also come under the new law. This includes just about all household servants who work any more than one day each week.

The system provides for benefit payments of at least \$20 monthly to qualified workers upon retirement after reaching the age of 65. Employers who fail to meet the April 30 filing deadline can be charged 5 per cent of the amount due for each 30-day delay, up to a 25 per cent maximum. There is also a 6 per cent annual interest charge on unpaid taxes.

Willful violations of the requirements — deliberate evasions, for example — can be punished more severely. Sentences could run as high as a \$10,000 fine and five years in person.

## 4-H Church Sunday To Be Observed Throughout County

Hillsboro — On April 29, approximately 20 programs will be presented in churches throughout Orange County by members of 4-H clubs in observance of national "4-H Church Sunday", according to Miss Virginia Cathey, assistant home demonstration agent. The theme is "Working Together for World Understanding."

In churches which will not have regular 11 o'clock services scheduled, due to this being a fifth Sunday, 4-H members will conduct special services of their own. In other churches, club members will participate in the services by welcoming people to the church, making altar decorations, ushering, taking up offering, serving as pianist, acting as superintendent of Sunday School and providing special music.

Club members have been asked to sit in a body in church, dressed in club uniform.

## Sixty-Nine Men Come Under New College Draft Law

Hillsboro — Sixty-nine draft eligibles from Orange County, now students in universities and colleges, will not be drafted until they have taken the aptitude tests scheduled by Selective Service for this Spring and Summer, and until their scholastic standings and test scores have been calculated.

Mrs. Billie Copeland, clerk of the local draft board, stated today that of the 69 college draft eligibles, 45 are now in class 2-A (occupational deferment) and 24 have postponements until the end of the school year. She reported that approximately 25 persons have made requests for application cards for the tests, but that at least half of these persons are registered elsewhere. "So many of the University of North Carolina students are registered in their own home towns," she said, "and numbers of these requests the application forms here."

Students who score 70 or better in the test, or who are in the upper ranks scholastically, may be granted occupational deferment in order to resume their education next fall, according to the ruling by Draft Director Lewis B. Hershey. However, final deferment of college students will remain at the discretion of the local draft boards.

According to Mrs. Copeland, only eight men will be sent for induction Friday out of the original 15 called for. She also stated that the local board has been notified that it will receive no calls for men during the month of May.

## Trailer Issue Set For Airing By Chapel Hill's Aldermen

### Judge Sends Pair To Higher Court For Theft

Hillsboro — The alleged theft of four shotguns and a few pieces of junk, all of which sold for \$4.75, resulted in a charge of breaking and entering and larceny for Dick McKee and J. B. Smith, both of whom were bound over to Superior Court with bond set at \$1,000 each, by Judge L. J. Phipps in County court Monday.

According to testimony, the defendants allegedly broke into the house of Robert Holt, a Negro resident near University station and stole four shotguns and some "junk" which they sold to a Durham junk dealer for the sum of \$4.75. McKee, a war veteran, refused to testify, but Smith, brother-in-law of McKee, told the court that he just drove the car when the former took the goods to a junk dealer and had nothing to do with the theft of the articles. McKee waived preliminary hearing and the court found probable cause in the case of Smith.

Dickerson driving on left side of highway, costs; James Wright, pleads not guilty to operating a disorderly house, continued.

### Three Carrboro Board Members Seek Re-Election

Carrboro — P. L. Senter, Roy Riggsbee and A. B. Poole have filed for re-election for Carrboro Commissioners. This is the only new development since last week in the municipal election to be held May 7th.

Sidney Barker, of the L. D. Hearne Grocery Store in Carrboro, R. S. (Teet) Lloyd, of the Lloyd Electric Company in Carrboro and O. M. Powers, of the Powers Groceteria previously have filed for town commissioners, all running for their first term of public office; however, others may enter the race either for town commissioner or Mayor, before the deadline next Wednesday April 25th.

Only the present Mayor, I. F. Hardee, and Dr. J. Sullivan Gibson, who is running for his first term of public office, have filed for Mayor of Carrboro at the present time.

New voters are again reminded that registration for all new voters began last Saturday April 14, in the Carrboro Town Hall, and will continue through Saturday April 28th. All new voters must register, to be able to vote in the town election on May 7th. R. B. Studebaker is serving as registrar.

### Dr. Herman Stevens Will Be Speaker At Baptist Revival

Hillsboro — Dr. Herman T. Stevens, public relations director of Campbell College, Buies Creek, and outstanding Baptist evangelist, will be guest speaker at revival services to be held at the Hillsboro Baptist Church all of next week at 7:45 o'clock.

The services, part of the simultaneous revival being held throughout the eastern section of the nation by the Baptists, will begin on Sunday with the acting pastor, Rev. Charles Maddry, speaking at the 11 o'clock hour.

Sunday night, Dr. Maddry and his wife will have charge of the program, talking to the group about the African mission field which they served for a number of years. The Maddrys will bring curios and dress which they accumulated during their years in Africa.

Dr. Stevens, who was an active Baptist pastor until his retirement about two years ago, will begin his series on Monday night at 7:45 o'clock, will continue each night through Friday and will preach again at the morning worship hour, Sunday, April 29.

The guest speaker is known as an interesting talker with a keen sense of humor. For the past 40 years he has been collecting knives of all kinds, each of which has a story or a moral lesson which he teaches through the facts concerning the history of the knife. Among the pastorate Dr. Stevens has held are Green Street Church, High Point, and Orcutt Avenue Baptist Church, Newport News, Va.

### Five From County Attend NCEA Meet In Asheville

Hillsboro — Five representatives of the Orange County School system attended the 67th annual meeting of the North Carolina Education Association in Asheville last week. They were Glenn T. Proffitt, superintendent of the county schools; Miss Cora Bomar, education supervisor; Miss Maude McCauley of Hillsboro School; Mrs. R. B. Studebaker of Carrboro School, and Mrs. Irene Pender of Aycock School.

Miss Ruby Leigh Davis of Chapel Hill School, was elected vice president of the north central district.

Resolutions passed by the NCEA called for: reduction of teacher-load to 30 students, with 25 as the ideal number; sick leave; \$2,400 base pay for teachers with 4 certificates and four years college; that personnel be paid by calendar rather than 20-day teaching month; Federal aid for education; local united forces for education groups.

North central district officers named were: Franklin Ross Jones, Henderson Junior High School, president; Ruby Leigh Davis, Chapel Hill School, vice president; Miss Pauline Taylor, Hugh Morrison High School, Raleigh, secretary.

### ELECTED

The Rev. I. E. Birdseye of Hillsboro was elected permanent Clerk of Orange Presbytery at its meeting Tuesday in Madison.

Governor W. Kerr Scott was named moderator.

Chapel Hill — The increasingly serious trailer problem is scheduled for a full dress review when the Board of Aldermen meet next Monday night.

A recommendation from the Town Planning Board that an ordinance be passed requiring all trailers located at points other than approved trailer courts, equipped with standard toilet facilities, be moved to such courts or vacated by September 1 has prompted the Aldermanic consideration.

Dr. O. D. Garvin, district health officer, and J. E. Wadsworth, University Housing Officer, have been invited to consult with the Board. Health hazards and recent easing of the housing situation in Chapel Hill were among the factors considered in the Planning Board recommendations, sent to the Aldermen in a letter signed by P. W. Wager, secretary.

The complete recommendation of the Planning Board was as follows:

"At its regular monthly meeting on Monday night, April 6, the Planning Board adopted a resolution to the effect that the Board of Aldermen be urged to adopt an ordinance requiring all trailers located at points other than in approved trailer courts, equipped with standard toilet facilities, to be moved to such courts or vacated by September 1, 1951. During the housing emergency trailers were allowed to locate in residential zones in violation of the zoning ordinance and contrary to normal sanitary requirements. Permanent residents of these neighborhoods have been most tolerant of these unsightly structures and of the health hazards introduced because of their sympathy for the occupants. They have not insisted on the enforcement of either the zoning or public health ordinances. But now that the student enrollment has sharply decreased and the housing situation has been greatly eased, these neighborhoods which have suffered from the invasion of trailers respectfully urge their gradual and eventually complete evacuation.

"The Planning Board believes that this is a reasonable request on the part of the affected neighborhoods and that it is also in keeping with the physical and social standards which Chapel Hill has set for itself. It respectfully urges the town authorities to seek the reestablishment and enforcement of these pre-war standards."

Concern over the bacterial count reports on milk furnished by some of the dairies serving Chapel Hill has also been expressed by the Aldermen and Dr. Garvin will also be asked to advise them on this point.

A report of the Chapel Hill Records Court for March showed receipts of \$2,940. 111 cases were heard, including 12 for speeding and 22 for public drunkenness, and other minor offenses.
