Farm, Home Hints

By Ruth Current State Home Demonstration Agent Sweet And Snappy - So Good! When looking for ways to vary salads, a bright-flavored dressing may turn the trick, say food specialists. As examples, they give recipes for two sweet-sour dressings, one thin, one thick, that go well with most kinds of salads made from tossed garden fresh greens. Sweet French Dressing: Ingredients to make 1 cupful: 3/4 cup sugar; 1/4 teaspoon salt; 1/4 teaspoon dry mustard; 1/2 cup vinegar; 1/2 cup oil; 1/2 teaspoon onion juice; 2 1/2 tablespoons finely chopped pimiento (fresh or canned); 1/4 cup finely chopped green pepper. To make: Combine sugar, salt, and mustard. Add vinegar and oil and beat well. Blend in onion juice, pimiento, and green pepper. Cooked Salad Dressing: Ingredients to make 1 1/2 cups: 1/2 cup sugar; 2 1/2 teaspoons sifted flour; 3/4 teaspoon salt; 1 teaspoon dry mustard; few grains cayenne; 1/4 teaspoon pepper; 2 teaspoon butter or margarine, melted; 2 eggs, slightly beaten; 1 cup milk; 1/2 cup vinegar. Cook over hot water until mixture thickens, stirring occasionally. By combining mayonnaise or whipped cream with this cooked dressing, a richer dressing may be made, if desired.
