County adopts policy for servicing busses for Chapel Hill schools The Orange County Board of

Education has adopted the following policy resolution:

That the Board approve servicing busses owned and operated by the Chapel Hill Schools in the same manner in which Countyowned and state-operated busses are serviced, provided:

1. Chapel Hill city schools pay the drivers and principals bus travel directly, and

2. Chapel Hill city schools insure their busses and be responsible for any damage or liability resulting from bus accidents, and

3. Chapel Hill city schools pay for all services rendered their busses including gas, oil grease, anti-freeze, labor, parts, tires and tubes as billed by the Orange County schools, making check payable to the State Treasurer, and

4. Chapel Hill city schools, in addition to the above payments, pay Orange County schools \$30 per month per bus for services, and

5. Orange County Schools provide a spare bus for Chapel Hill City Schools when their busses are not able to operate.
