NO EXPLOSION, BUT CONTINUAL sporadic outbreaks of violence were predicted in the Union of South Africa by Dr. Guy Johnson in a luncheon talk before the Faculty Club yesterday. The UNC sociologist and Mrs. Johnson recently returned from a year's leave most of which they spent in Africa. Mozambique and Angola, on the other hand, are now the breeding grounds for situations even worse than the Congo, he declared. During their trip the Johnson took 1,500 color slides, some of which he projected yesterday.

MRS. They've served notice declaring the process serving for the hearing was improper. They moved to dismiss the hearing until after the criminal trials are completed and put into the record that by their appearance there they were not acknowledging the legality of the procedure.
