

HE'LL KEEP THE WEIGHTS-Orange County Superior Court Clerk Edwin M. Lynch has been officially designated by the county commissioners as Keeper of the Weights, a 20-piece set of standard weights and measures bought for the County in England in 1758 and still owned by the County.
