The Veterans Corner

(Editor's Note: Below are authoritative answers by the Veterans Administration to some of the many current questions from former servicemen and their families. Further information on veterans benefits may be obtained at any VA office.)

Q—Do just the facts that I have sold my home and secured release of liability to the government for the original loan make me eligible for a new GI loan?

A—No. In such cases, entitlement to another GI loan is restored only when the property:

- a. was taken by a governmental agency for public use.
- b. was destroyed by a natural hazard.
- c. was disposed of for compelling reasons, such as health, employment transfer, change to a better job in another city, or other reasons considered sufficient by the VA.

Q—I am a World War II veteran with a Certificate of Eligibility for a GI loan issued several years ago. Is it still good?

A—Since eligibility of some World War II veterans has already expired, based on

their length of service, you should submit your certifi-

Q—I read recently that a cate to the VA for review to determine your own individual date of expiration. veteran having a ten percent dental condition could not qualify for the new insurance. Is this correct?

A—No. If the dental or oral condition is compensable, it would be accepted, to qualify you for the new GI insurance, if you are otherwise eligible.

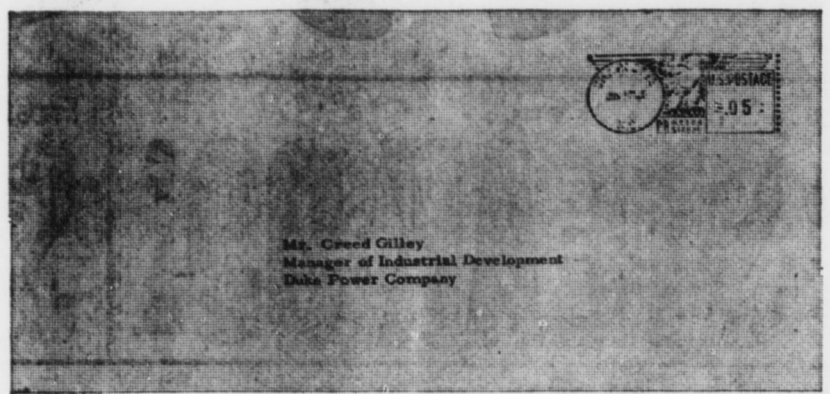

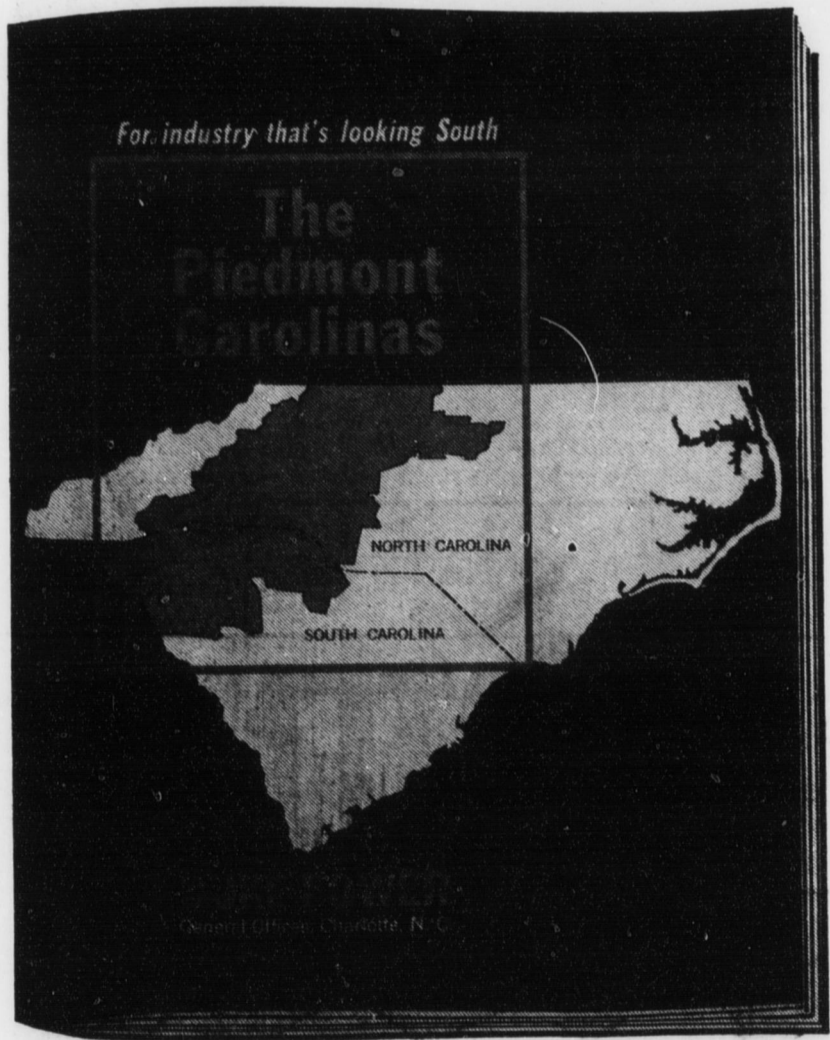

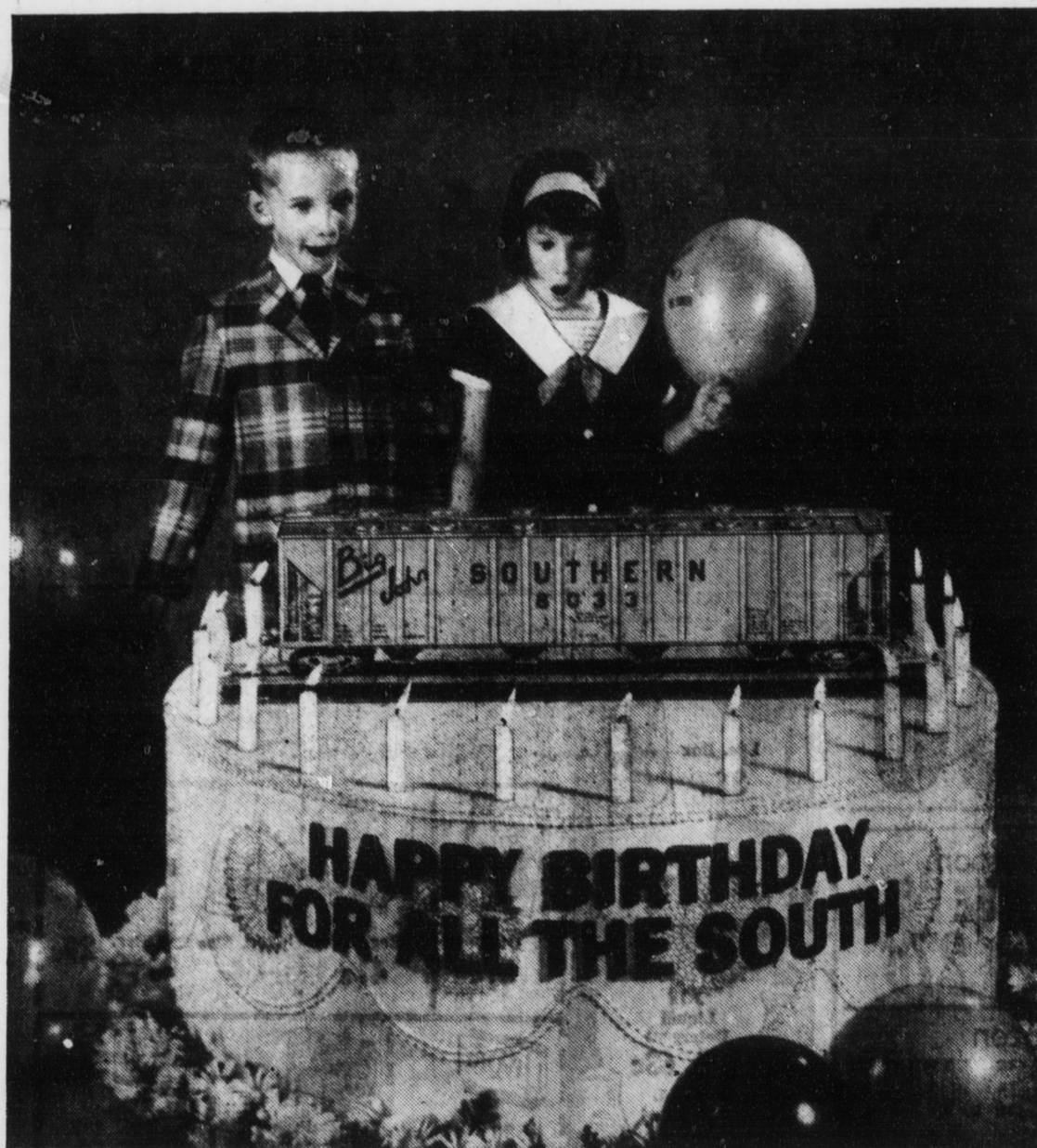
