Bud Sell's Stepsister Murdered In D. C.

Mrs. Houston Shoaf, 61, stepsister of J. C. Sell and a native of Davie County, was beaten to death in a robbery-assault at her home in Washington last week. A neighbor was wounded.

The Journal has learned that two teenage Negro youths have been arrested and charged with the crimes.

Mrs. Shoaf's address was 144 14th Street, S.E., Washington, D.C.

Mrs. Shoaf, the former Beatrice Beck, was reportedly in her house behind locked doors when two men broke into the house in late afternoon. Her husband was reportedly out grocery shopping.

When he returned he found his wife, brutally beaten, and a neighbor, who was stabbed in the stomach. The neighbor, a man who lived across the street, apparently had come to Mrs. Shoaf's aid.

Mrs. Shoaf died at 3 a.m. in the D.C. Memorial Hospital.

Mrs. Shoaf, daughter of Jesse B. and Lula Grubb Beck of Rt. 4, Mocksville, was educated

275 Pints Of Blood Sought Here Tomorrow

The Red Cross Bloodmobile Unit will be in Cooleemee tomorrow from 11 a.m. until 4:30 p.m. The site of the visit will be the Fellowship Hall of the First Baptist Church.

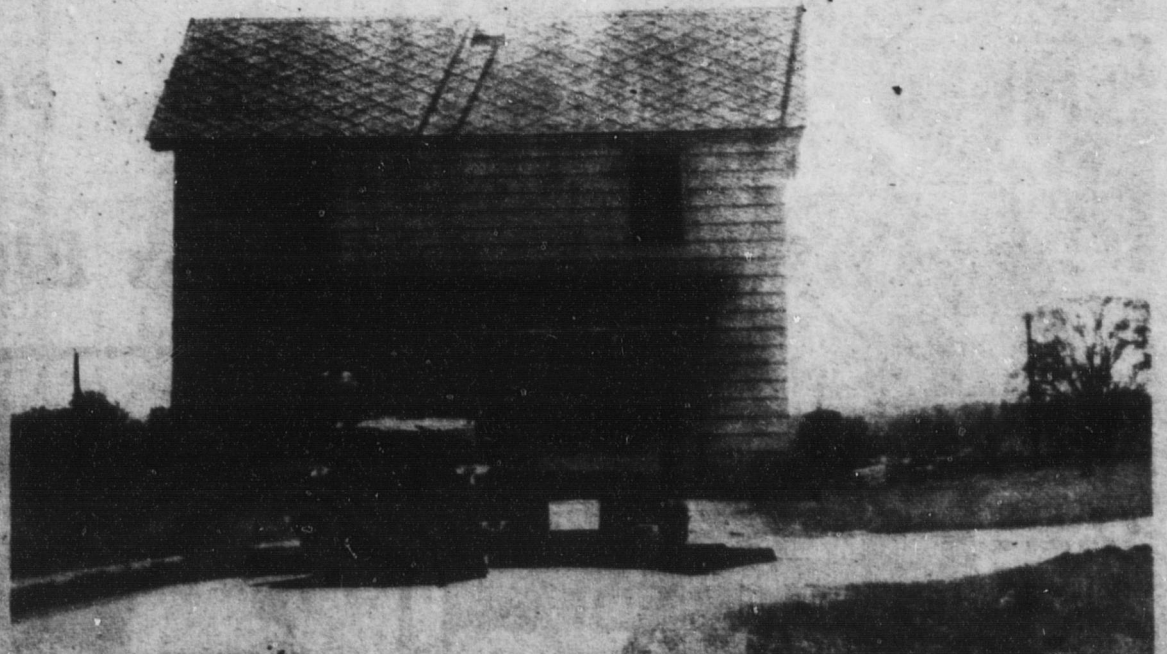
This is perhaps the most important visit for Davie County since entering the Bloodmobile Program. This will be the last visit in the current fiscal year which ends June 30, 1968. To date our blood usage far exceeded our blood collections. Projecting our blood usage for the remainder of the fiscal year on the experience of the first 8 months, we will need approximately 275 pints to meet our actual blood usage.

It only takes a few moments to give blood — the gift of a lifetime. The blood we give could easily be the determining factor in life or death for someone, even ourselves or some

member of our family. We have moral obligation to ourselves and to each other to donate our life-saving blood. Remember it is so little to give for so much to save. While you save a life today, you protect your family's tomorrow. No where can you get so high a return on such a small investment.

Each of us should work through our place of employment, our church, and the various civic clubs to meet these life-saving needs for the people of our county.
