FIRST TRACT

Being in the town of Farmville on the west side of Main Street and beginning at the N. E. corner of Bettie Joyner's line and runs 100 feet in a westerly direction along said Bettie Joyner's line; thence at right angles in a northerly direction and parallel to Main Street 30 feet; thence at right angles in an Easterly direction 100 feet to Main Street; thence along Main Street in a Southerly direction 30 feet to the point of beginning.

SECOND TRACT

One lot in the town of Farmville on the West side of Main Street, beginning at the S. E. corner of A. L. Joyner's lot, and runs with said A. L.
