### PERSONAL PRIDE AND THE LAW

(By J. B. Lewis) The people of the Town of Farmville can now show the pride they take in the beauty of their homes and their town: the weeds are growing on vacant lots and along the sidewalks of those occupied; there is a law providing that it shall be a misdemeanor for the owner of a vacant lot to allow the weeds to grow thereon, but the owners could take pride in their town and keep the vegetation cut or so controlled that the town would be beautified, and those who occupy homes should take a personal pride in the place they live and make it as beautiful as possible.

All persons owning vacant lots are requested to keep the weeds cut for two reasons: "To beautify the Town and to obey the law; all persons occupying homes are requested to cut the weeds and grass growing on the fences to demonstrate their personal pride in their homes and the town."
