Eddie Cantor is known to millions of people in this country and other nations through his performances on the stage, the screen and in front of the microphone. The Jewish comedian has brought laughter to many and his reputation is built upon comedy. At the same time, he has another side seldom seen in public.

Recently, he addressed an audience of Jews, speaking to them about the persecutions which are being directed against his people in some nations. Mr. Cantor urged his hearers to answer Hitler with "our self-respect, our love of God and man," saying "I am certain that if we Jews cling to our faith and practice leading honorable lives, helping our fellowmen whoever they may be, irrespective of race, color or creed, we will again triumph over our enemies as Moses did in times gone by."

Mr. Cantor's advice to Jews, with slight alterations to suit other religious faiths, can be followed with considerable profit by people everywhere.
