A Few Suggestions.

Editor Gazette .-- I ask space in your valuable little paper to make a few sugg stions to our farmers. In view of the exteaded drought many farmers are despairing of getting their lands broke in time for wheat. It is the experience of all that the earliest plowing for wheat is best, that wheat sowed on have plowed land does not do so well, that is the case in ordinary seasons when we have rain enough to produce large crops of grass and weeds which ex-baust the available plant food in the soil. Such crops should be turned under in time to decompose before wheat is sowed. There are very small crops of vegetation on land this season on account of the drought, and instead of exhaustion, all lands are rested and will be in good condition for seed if not broke b-fore October ; or lands broke in S-piember and October after a very day summer and fall will do as well as if broke in August. Corn and cotton lands will be lean and in the best possible condition for small grain, and the wheat crop is always good after a dry summer. Corn and cotton crops will come off much earlier than usual, in fact, gathering the fall crops will be a light j b, most farmers will have but lit tie to do bat to sow small grain. Qur and wheat. 



Saturday evening last, in Union county, four miles west of Monroe, Key Seer st shot and almost instantly killed Wash Helms. From a gentleman from Monroe who was in the city yesterday a peporter of the Charlotte Observer learned some of the particulars.

Secrest is a farmer and miller of Union c unty and Helms was an employe of his ton, Chester, S. C ; H. H. Smith, Hun ers- and lived in the same yard. They had been in Monroe Saturday and bad something of L zzie Cornwell, Chester, S C.; J. B. M. a quarrel during a settlement of some accounts bet seen them. Helms was dranking and all the way home he was interrupting and stopping Secreat's team, driven by a

little son of the latter. When they reached home, Helms, followed Secrest into his house, continuing to curse and make himself very off-osive. Secrest ordered him out of the house and he retired to the gate, where he still cursed and defied Secret. Mr. Alexander, father-in-law of Secrest, a gentleman between 50 and 60, went out and told II lins to go away and not make such a fool of himself.
