POSITION FOR MR. CLEVELAND.

He is more likely to take the Presidency of a Trust Company than a Professorship.

Washington Dispatch to Baltimore Sun, May 8.

The last news received here in reference to the prospective business purposes of ex-President Cleveland connects his name with the presidency of a new trust company now in process of formation in New York city.

Friends of Mr. Cleveland in Washington think that he would hesitate before accepting professorship in Princeton, as was lately intimated, because of the necessity of being tied down to routine and details.

However, in case of certain stipulations being agreed to, he possibly might try it for a while as an experiment.

The presidency of a big trust company is an entirely different matter. Its duties could be arranged so as not to be onerous, and the weight of his name above would command a fine salary.

Mr. Cleveland would accept of a corporation unless he was at all times satisfied with its methods and its honorable conduct of affairs.

It has been known in Washington for some time that ex-President Cleveland is anxious to get into something suitable and congenial that will add to his income. Indeed, it might be said to be almost a necessity.

The most exaggerated stories have been printed of his speculations and his speculations. Instead of being a millionaire, his possessions at a liberal estimate will not foot up quite \$500,000.

In this, of course, is included his property in Princeton and Buzzard Bay houses. This latter is destined, it is said, to be very valuable some day, but just now it is totally unproductive.

With a wife and four children, five or six thousand dollars a year, the full extent of his income, is not very much for an ex-President of the United States. So, at his friends anticipate, Mr. Cleveland will most probably enter upon an active career when the position that is agreeable can be found.
