Yorkville Enquirer, 14th. Mr. T. J. Nichols of Yorkville No. 6, sold three more bales of his long staple cotton a few days ago, this time at 191/2 cents a pound. Mr. Nichols says he had in 2 1-4 acres of this cotton and made two bales weighing 430 pounds each. A cropper who planted 12 acres, and who did not work it as well as he should have done, made five bales averaging: about 490. The cropper cleared about \$25 on his 12 acres, and it is the opinion of Mr. Nichols, that if he had planted the ordinary short staple cotton, he would have come out in debt.
