AN INCORPORATED FARM.

The Ware Heirs Inaugurate Unique Experiment in Farming-Mr. J. White Ware, of Gastonia, One of the Incorporators.

The article published below is from The Yorkville Enquirer of the 4th. It will be read with no small degree of interest by many Gazette readers, for whose benefit it is here reproduced. One of the incorporators. Mr. J. White Ware, is a resident of Gastonia.

Following is the article:

One of the first experiments with an incorporated farm is to be made in York county. This experiment' is to be made on the Williams old place, now owned by the heirs of the late Mr. Ware of Kings Mountain, N. C., who some time ago purchased the property in partnership with Mr. W. G. Hughes. The idea of the Wares is to put the property in such shape that the different owners will be free to do with their holdings as the others. They believe also, that the corporation plan will insure the most profitable development of the property. The following comments from The Farmer's Union Sun are interesting:

The following clipping from The Manufacturers' Record, Baltimore, Md., shows a movement toward more system in farming:

"S. C., Rock Hill-Farm.-Ware farm incorporated with \$30,000 capital stock by J. W. Ware, S. L. Patterson and L. L. Ware; will cultivate farm lands and operate cotton gin and grist mill."

Now, let us suppose that co-operation could get off the paper sufficiently to become a reality and that a dozen or more good farms in a neighborhood could be put together into a joint stock company, regularly incorporated under the laws of the State, without each farmer losing his individual title to his land, They could then put under one business management and each farmer under such a plan would work his own farm under the direction of experts employed to superintend the different departments. The system of bookkeeping and records would show all work done and a complete record of all expenses and sales would be kept. Each farmer could keep for his own use all the products of his farm that he wanted, these being priced to him according to the records at the exact cost of production, and all that he did not wish to keep could be turned over to the business head of the corporation to be sold. All buying and selling would be done by the central business head of the corporation and these commodities and products could be handled in large lots, thus reducing many expenses.

Under such a system with proper expert supervision and management, each farmer would not lose his individuality and power of initiative. as his work would be done in consultation with experts. The possibilities under this system would be greatly increased. Scientific and economic production would be much better secured. Waste could be more easily eliminated. The individual farmer would get a better return for his outlay of time and money than under the present system.

Of course the success of such a corporation as this would depend upon being managed by brains and Christian character. Such men can be found, however.
