He cited as instance, that opposition to the rivers and harbors bill comes mostly from the cities. "Country folks," he said, "know better than to criticise appropriations for the improvement of rivers; they know that when you improve a river you help every man within a radius of two hundred miles of that river." One reason for this preponderance of intelligence is that the man in the country has more time to devote to the study of the news as he finds it in his papers. As a general thing, the farmer reads more papers and pamphlets and public documents than does the city man, and he reads with one object in view-information. As to our confusion on occasion: We have had country people to take up some subject of public interest and discuss it with a degree of intelligence that would make us blush for our own lack of reason and information

every member to be present as the election of officers for the ensuing year will be held.


