The typographical work is of a high order and the volume of 187 pages presents a most attractive appearance. Trinity offers three groups of studies leading to the degree of Bachelor of Arts. Excellent opportunity is offered to those who wish to study Electrical, Mechanical, or Civil Engineering. The Department of Education offers a number of courses designed for those who expect to become teachers. A statement of the three years' course of study leading to the degree of Bachelor of Laws is given.

The catalogue shows that during the year ending February 1, 1910, 1,903 bound volumes and 1,211 pamphlets were added to the library.

The total attendance in Trinity College and Trinity Park School for the current year is 543, with the total number of teachers and officers 49.
