Heyburn Makes an Ass of Himself Again.

Senator W. B. Heyburn, of Idaho. dislikes "Dixie." He created a sensation at a reception given to Congressman T. R. Hamer, at Wallace, Idaho, Thursday night by stopping the orchestra while the musicians were playing the popular strains. Col. Hamer had just finished his address and the orchestra had started a medley of well known airs. About the sixth number in the medley was "Dixie." The Senator leaped to his feet, strode across to the musiciana and cried out: "This is a Republican meeting. We want no such tunes here."

The amazed musicians stopped immediately. The Senator strode back to his seat. After a moment of closed the meeting.

ROOSEVELT DEFEATED.

Ex-President Fails of Election a Temporary Chairman of New York Republican Convention by Five Votes-His Second Set-Back.

New York, Aug. 16 .- Theodore Roosevelt matched strength with the "old guard" of the Republican party in New York State today and met decisive defeat. The Republican State committee, in session here, by a vote of 20 to 15, refused to recommend him for temporary chairman of from Wilmington and all local the State convention which meets at Saratoga on September 27. Instead Vice President James S. Sherman was selected.

This is Col. Roosevelt's second defeat at the hands of the "old guard," the first having been the Legislature's refusal to pass the Cobb direct primary bill, although Mr. Roosevelt especially endorsed it. With his setback today plans for harmony within the party in the State received a severe set-back; and as soon as Colonel Roosevelt heard the news he issued a statement in which he enrolled himself as a progressive, so far as the New York State situation goes. The statement follows:

"To the various persons who asked me whether I would accept the position of temporary chairman of the State convention I said that I would do so only if they were sure after knowing my attitude that they desired me, because my speech would be of such a character that it might help if the convention nominated the right kind of a man, on a clear cut, progressive platform; but that it would hurt if neither the right kind of a man were nominated nor the right kind of a platform adopted."

Although repudiated today, it does not necessarily mean that Colonel Roosevelt will not be temporary chairman, after all. The convention delegates themselves will decide who is to open the meeting and deliver the "keynote speech."

In the interval between now and September 27 it is expected that the struggle between the organization and Roosevelt-Hughes forces will be carried into every corner of the State and that the chief issue will be at the primaries for the election of Roosevelt or anti-Roosevelt delegates to the convention.
