they were all on our side. Part of the British ships went out today but others came in. There are two anti-aircraft guns on this ship. We are anchored in the Firth of Forth now. There is an exceptionally large bridge across the Firth above where we are anchored. It is quite a noted bridge.

I saw the King and Queen of England and the Prince of Wales last Wednesday when the king and prince reviewed us all. I went on board a British submarine

This has been a happy day for us. This morning a notice was posted saying that we, the Sixth Battle Squadron, would leave here for Hampton Roads in the near future. Later in the day I got a bunch of letters from the States. Unless our plans are changed we will leave here for the States in a few days. I expect to try and get a furlough then, and spend part of the holidays with you. Love to all,

From Sergeant Geo. W. Wilson.

Mrs. W. W. Wilson recently received the following letter from her son, Sgt. George W. Wilson of Co. A, 115th Ma chine Gun Battalion:

Le Mans, France, Nov. 24, 1918. Dear Mother: I wonder what you all are doing this beautiful day? Suppose you are busy though, if it is as pretty a day over there as it is here. Seems like the sun shines brighter over here since the war ended. It seems like a new place. We have been busy this week as our division is moving. We were the first to arrive at this place, so we were detailed to unload the division and we have been busy day and night this week. The company works in two shifts, that is part are on for so long then the others go on. We don't get much sleep, but we are expecting to get through tonight. Have already unloaded 18 trains and haxe six more yet. It has been pretty hard, but still we had a lot of fun. What time we are not busy we build up a good fire and chat, make coffee and cat some thing if we can find anything to eat. We are getting American rations now since we got here, as we are in the American sector. We have been with the British all the time until we came here and were issued British equipment and rations. Believe me, I am glad we are where we can get good old American bread. Of course, the other was all right, but we like "ours" the best.

We are anxious now for the day to come when we can start back to dear old J. L. Price, to secure the payment of U. S. A., but when that will be we don't know. France is a beautiful country alright but give me America. The town we are in now is about the nicest one I have been in. It is back where there has been no war, though.
