C., and bounded on the north by H. W. McPhaul, and D. S. Liles; on the east by D. Henly McNeill; on the south by H. S. Kirkpatrick, and on the west by J. W. and A. D. 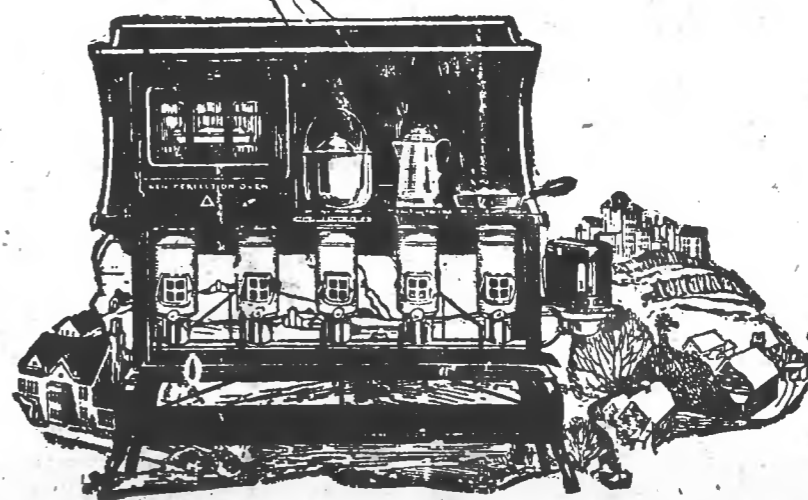
